

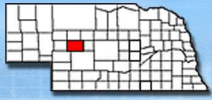
McPherson County Board Minutes

The McPherson County Board of Commissioners met as per adjournment of December 14, 2021 for the annual statutory meeting and regular monthly meeting. Notice of meeting having been published in the Stapleton Enterprise, issue dated January 6, 2022. Chairman Nason called the meeting to order at 9:03 AM. Board members, Jeffrey Arensdorf, Brett Nason and John Bryant were present. Also present were the Highway Superintendent Tom Werblow, Weed Superintendent Rich Cook, County Attorney Whitney Lindstedt, County Sheriff Tom Burch and County Clerk Kathy Hoberg. Road worker Ed Black and member of the public Harold Arensdorf were also present. The Chairman noted the public meetings law which is posted in the meeting room. 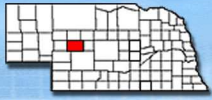

Rich Cook, McPherson County Weed Superintendent presented an Annual Noxious Weed Report to the commissioners. Each commissioner was given a copy of the report and it was signed by the board chairman.

Nason made a motion to appoint Rich Cook as McPherson County Weed Superintendent for 2022, increasing the wage to \$13.00 per hour. Bryant seconded. Voting Aye: Nason, Bryant and Arensdorf. Voting Nay: None.

Discussion was made on the county roads with Ed Black. The road department has been working on equipment maintenance in the shop. They are purchasing steel and will be building auto-gates. Ed reports that the International truck is in need of a new transmission. The county will receive a cost estimate from Inland Parts.

The 2022 schedule for Road Overseer was set as follows:

Jan-Feb-March – Bryant **April- May- June** – Nason **July-Aug-Sept** – Arensdorf **Oct- Nov- Dec** – Bryant.

Bryant made a motion to adopt and approve **RESOLUTION #2022-1**, McPherson County Road and Labor Prices for the year 2022, increasing the wages by \$1.00 per hour for employees with 2 years or more experience, leaving all other prices to pay and charge, the same as 2021. 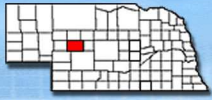

Bryant moved to appoint Tom Werblow, Ed Black and Brett Nason to the Safety Committee for 2022, with Brett Nason the Chairman. Nason seconded. Voting Aye: Bryant, Nason and Arensdorf. Voting Nay: None.

Motion made by Arensdorf and seconded by Bryant to adopt and approve **Resolution #2022-2** appointing Tom Werblow as McPherson County Highway Superintendent, with a total salary of \$9000.00, for the year 2022. Voting Aye: Arensdorf, Bryant and Nason. Voting Nay: None.

Motion made by Arensdorf seconded by Bryant to adopt and approve **Resolution #2022-3** Setting the salaries for elected County Attorney and elected County Surveyor for the next term of office, starting in January 2023. The annual salary for the office of County Attorney is established at \$6,000.00 per year for the years 2023, 2024, 2025 and 2026. The salary for County Surveyor is established at \$400.00 per year for the years 2023, 2024, 2025 and 2026.

Bryant moved to approve and adopt **Resolution #2022-4** designating the following depositories for McPherson County in 2022. Arensdorf seconded. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None. Adams Bank & Trust, First National Bank, Nebraskaland National Bank, Western Nebraska Bank of North Platte, Nebraska, Community First Bank of Stapleton, Nebraska, and the Nebraska Public Agency Investment Trust of Lincoln, Nebraska.

Motion made by Bryant, seconded by Arensdorf to adopt and approve **Resolution #2022-5** giving the McPherson County Treasurer the authority to invest funds for the year 2022. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Bryant moved to adopt and approve **Resolution #2022-6** appointing Whitney Schroeder Lindstedt as the McPherson County Attorney for the year 2022. The hourly wage being set at \$11.00 per hour for 100 hours per pay period, plus expenses, with the same insurance benefits which are offered to all full-time McPherson County Employees. Seconded by Arensdorf. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Motion made by Arensdorf seconded by Bryant to adopt and approve **Resolution #2022-7** appointing Bonnie Edwards of North Platte, Nebraska, to act in the capacity of McPherson County Surveyor for the year 2022. No Fees will be charged to McPherson County. Clients will be charged regular rates for the survey work. Voting Aye: Arensdorf, Bryant and Nason. Voting Nay: None.

Nason moved to appoint John Bryant and Alternate Brett Nason to the **911 Advisory Board**. Arensdorf seconded. Voting Aye: Nason, Arensdorf and Bryant. Voting Nay: None.

Arensdorf moved to appoint, upon their approval, Jerry Moritz, Will Coffman and Kent Fisher to the **Planning Commission** and Mike Krull, Dean Seifer, and Billie Burch (alternate) to the **Board of Adjustment** for a three-year term to begin January 2022. Bryant seconded. Voting Aye: Arensdorf, Bryant and Nason. Voting Nay: None.

Members of the Fair Board will be contacted and appointments will be made in February.

Arensdorf moved to appoint Kathleen Craig to the **Extension Board** for a three-year term to begin January 2022. Nason seconded. Voting Aye: Arensdorf, Nason and Bryant. Voting Nay: None.

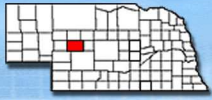

The commissioners reviewed and signed the Quarterly Fee Reports from the County Sheriff and the County Clerk. The Annual Secretary of State Report of County Officers was signed by each official.

The commissioners reviewed and approved the 2022 Nirma Insurance Schedule for McPherson County.

Motion was made by Nason and seconded by Arensdorf. Voting Aye: Nason, Arensdorf and Bryant. Voting Nay: None.

Replacement of the courthouse generator, which is not working, was discussed. The current generator powers the courthouse, the fire hall which is the Emergency Operations Center and the fair building which is the Emergency Community Shelter. The commissioners are reviewing several options which include repairing the current generator, or replacing it with two generators or a separate generator for each building. The matter will be discussed at the February meeting.

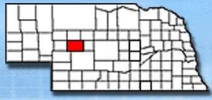
McPherson county had applied for a grant to fund a Scrap Tire Clean -up Program. We were informed by the Nebraska Department of Environment and Energy that the application would not be funded for the following reason: Due to limited funds, scrap tire applications with duplicate area coverage were not funded this grant year. Another scrap tire clean-up event will be held in Stapleton in 2022 and this event will include McPherson County. We do not have a date for the program in Stapleton at this time.

The commissioners discussed potential items which could be purchased with the American Rescue Plan Act money. A Final Rule has been released by the Department of Treasury which will take effect in April, 2022. This ruling helps clarify qualified uses for local governments and will help the board decide on the best use of the money for McPherson County.

There being no further business, the meeting was adjourned at 11:40 AM. The board will meet again for their next regular monthly meeting on February 9, 2022.

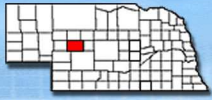

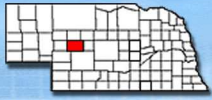

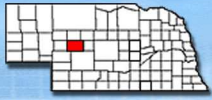
Harold Arensdorf was present and addressed the commissioners concerning a tree which is beside his residence but is also located on county property. The tree is causing problems on his property and he requests that it be removed. John Bryant will contact Weaver Tree Service and discuss the details of the removal. Due to the fact that the tree is partially or completely on county property, the county will cost-share the removal of the tree with Mr. Arensdorf.

The commissioners discussed roads with Ed Black. Ed reports that the road department has been building auto-gates and they are all complete. The road department needs to replace several delineator reflectors and needs safety flags for wash-outs and road hazards. Tom Werblow will locate these items on-line and forward the information to the clerk for ordering.

Arensdorf made a motion to approve the February Road Plan as presented by Bryant. Nason seconded. Voting Aye: Arensdorf, Nason and Bryant. Voting Nay: None.

At 9:45, a Safety Committee Meeting was held. Those present were, Tom Werblow, Whitney Lindstedt, John Bryant, Brett Nason, Jeff Arensdorf, Ed Black and Kathy Hoberg. Werblow gave flyers and a presentation on Battery Charging Hazards and the Dangers of Acids, Bases and Alkali.

At 10:00 AM, the annual One & Six- Year Road Plan Hearing was held in the courtroom. Notice of Hearing having been published in the February 3rd edition of the Stapleton Enterprise. Those present were Highway Superintendent Tom Werblow, Jeff Arensdorf, John Bryant, Brett Nason, Whitney Lindstedt, Ed Black and Kathy Hoberg. Everyone was given a copy of the plan. Tom Werblow addressed those in attendance with explanation of the plan. There were no members of the public present for comment. Bryant made a motion to approve and adopt the 2022 One & Six- Year Road Plan as presented. Arensdorf seconded. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None. The hearing was closed at 10:30 AM.

The board discussed appointments to the Fair Board. Jeff Arensdorf will contact the current members (terms expiring in 2022) and confirm whether they want to remain on the board or if they need to be replaced. Brett Nason will contact replacements if necessary.

The commissioners reviewed and approved a quote for replacement lids for the dumpsters in McPherson County. The lids will be ordered from EJS Supply Company of Iowa. The cost of the lids with shipping is \$1239.00, which is below the limit for the bidding process and is considered maintenance costs.

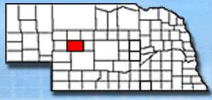
The board discussed items they are considering for purchase with money received from the American Rescue Plan Act. The commissioners reviewed a price quote from Platte Valley Communications for Fire/EMS Radio Equipment and a quote from FYR-TEK Sales and Service of Fire and Rescue Equipment, for an Ambulance Power Load. Arensdorf made a motion to accept the price quotes and designate approximately \$67,300.00 of the ARPA money for purchase of the radio equipment and ambulance loader. The purchase of the items to take place after April 1, 2022, when the Final Rule for the American Rescue Plan Act takes effect. Bryant seconded. Voting Aye: Arensdorf, Bryant and Nason. Voting Nay: None. Resolutions for the purchases will be drawn for review and adoption at the March commissioner's meeting.

There being no further business, the meeting was adjourned at 10:55 AM. The board will meet again for their next regular monthly meeting on March 9, 2022.

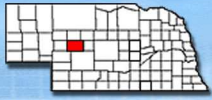
This is the only proposal received at this time and the commissioners have reached out to other potential bidders for proposals.

The commissioners met with Elaine Menzel, legal counsel for Nebraska Association of County Officials, who was present to introduce herself and provide an update on NACO. The Association has purchased property in Ogallala and will be building a central location for meetings and offices. MCPHERSON COUNTY BOARD OF COMMISSIONER'S PROCEEDINGS
DECEMBER 19, 2022 *CORRECTED*

The McPherson County Board of Commissioners met as per adjournment of an Emergency Meeting which was held December 12, 2022, for their regular monthly meeting. Notice of meeting having been published in the Stapleton Enterprise, issue dated December 8, 2022, and Notice of date change from December 14th to the 19th, which was posted at 3 locations in Tryon, 5 days prior to meeting. The meeting date was changed due to hazardous weather which occurred on December 14, 2022. The meeting was called to order at 9:00 AM by Chairman Nason, who noted the Open Meetings Law, which is posted on the North wall of the meeting room. Members John Bryant, Jeffrey Arensdorf and Brett Nason were present. Also present were the Highway Superintendent Tom Werblow, County Attorney Whitney Schroeder, Road Worker Ed Black, Sheriff and Emergency Manager Tom Burch and County Clerk Kathy Hoberg. Also present was member of the public Dave Hardin, Arthur County Highway Superintendent.

Bryant moved to approve the minutes of the last meeting as presented. Arensdorf Seconded. Voting Aye: Bryant, Arensdorf and Nason Voting Nay: None.

The claims had been approved at an Emergency Meeting which was held on December 12, 2022.

The Commissioners examined and discussed **RESOLUTION # 2022-21** Local Emergency Operations Plan.

Arensdorf made a motion to adopt and approve and sign the resolution as presented. Bryant seconded.

Voting Aye: Arensdorf, Bryant and Nason. Voting Nay: None.

The Commissioners discussed county roads with Ed Black. Ed reports the road crew has been working on snow removal.

The board reviewed a National Functional Classification System Map which was sent to the county by Nebraska DOT. Tom Werblow will examine the map and there will be further discussion at the February Commissioner's meeting.

Chairman Nason signed a road easement received from Colton and Kathleen Craig.

Arensdorf made a motion to approve the Road Plan for December which was presented by Bryant. Nason seconded. Voting Aye: Arensdorf, Nason and Bryant. Voting Nay: None.

There was a Safety Committee Meeting Held. Those present were, Jeff Arensdorf, Brett Nason, John Bryant, Whitney Schroeder, Tom Burch, Ed Black, and Kathy Hoberg. Werblow gave flyers and information on the *Dangers of Cold Wintry Weather*.

The board acknowledged the election of Kerri L. Kramer to the office of McPherson County Treasurer, term to begin January 5, 2023. The commissioners approved a letter giving Kerri L. Kramer authority to administer and be listed as signer on all accounts listed for McPherson County Treasurer as of January 5, 2023.

The board received and examined the Fund Balance Listing for December provided by the Treasurer.

The Village of Stapleton requested approval from the commissioners to place a recycle bin trailer in Tryon. There will be no fee to McPherson County for the trailer. McPherson county will deliver the full bins to North Platte and deliver the paper to Stapleton where it will be baled. The purpose of the recycling program is to cut down on the amount of trash being hauled to the land fill and lowering costs to the counties. Bryant made a motion to try the recycling trailer for a trial period, as long as the trailer is not owned by McPherson County and the county is not responsible for the trailer. The trial period will be six months and will determine whether the public is willing to sort items properly and use the bins as expected.

Arensdorf seconded. Voting Aye: Bryant, Arensdorf and Nason. Voting Nay: None.

Bryant moved to appoint Berva Arensdorf to the McPherson County Extension Board. Arensdorf will complete the 3-Year Term of April Gaedke who has resigned. The term expires in January 2024.

There being no further business, the meeting was adjourned at 10:05 AM.

The Board will meet again at 9:00 AM on January 5, 2023, for a Special Meeting. The purpose of the Special Meeting will be to appoint Tom Burch to continue as McPherson County Sheriff until a new Sheriff is appointed. The board will then meet on January 11, 2023, for their annual statutory meeting. These meetings will be held at the McPherson County Courthouse in Tryon and are open to the public.
